## Effective January 1, 2025: Mandatory Updates to Required California & Federal Employment Notices

### 2025 California and Federal Employment Poster:

Eight of the 18 required Notices on the new 2025 California and Federal Labor Law poster reflect mandatory updates effective January 1, 2025. You must post a compliant Employment Poster in a conspicuous place in the workplace where all employees and applicants can see it. The poster also must include information about your workers' compensation on benefits, pay day schedule and emergency contacts. You may need to order several to ensure that your business, branches and satellite offices are displaying the poster according to the law. Failure to comply can result in severe penalties and fines by the State of California.

*If any of your company's workers are Spanish-speaking, you will also need to order the Spanish version.*



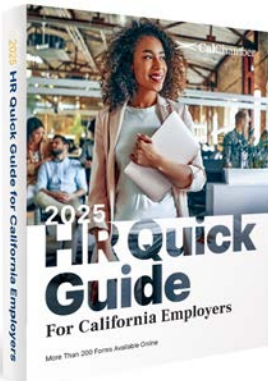
### Required 2025 California Wage Order Posters:

Wage Order Posters to display in your workplace as required by California law to post at least 1 of the 17 and are applicable to your business industry. Each all-in-one poster combines the multiple pages of an industry-specific Wage Order. Call us to help you determine which of the 17 California Wage Orders you need to post. (There may be more than one.) Updated postings are required as of January 1, 2025.

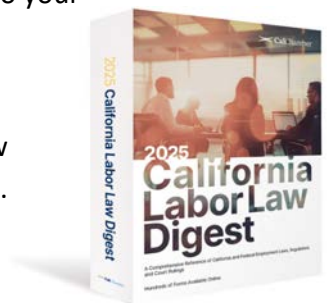
